Horizon Government Affairs conducted this analysis to identify where key candidates are on healthcare issues, with a focus on races that are expected to be close.

This analysis relied upon rigorous research using various online resources and in-house expertise. Race ratings are based on current information from Cook Political Report at the time of publication.

As always in elections, things can and likely will change as we approach election day.

ARIZONA



SENATE (Lean Democrat)

SEN. MARK KELLY (D) Health Policy

Incumbent | Sen. Kelly does not prioritize healthcare policies in his campaign materials or during his federal career. He did support the Inflation Reduction Act (IRA) and its prescription drug provisions.¹ Sen. Kelly does have a series of citizen advisory groups² and while no specific healthcare group exists, a few do touch upon particular community health issues, like the Senior Citizens group on vaccine shortages and the need for lower prescription drug costs or the COVID-19 group on data sharing and community health center support.

BLAKE MASTERS (R)

Health Policy

A Stanford-educated lawyer, Masters, was the president of the Theil Foundation, which promotes science and innovation; he also served as COO at Thiel Capital, an investment firm that specializes in the technology sector.³ While he does not have specific healthcare priorities (his focus: tech and China), his background and pro-Trump agenda indicates he will likely vote party line.

HOUSE

AZ-01 (Republican Toss Up)

REP. DAVID SCHWEIKERT (R)

Health Policy

Incumbent | Rep. Schweikert believes Americans need more choices and a competitive insurance marketplace. While healthcare is not a priority of his campaign website, he has been an active member of the House Ways & Means Committee, leading bills on telehealth and health technology. His official website⁴ focuses on lowering out-of-pocket costs and premiums, increasing adoption of technology, improving transparency, and highlighting value-based care.

JEVIN HODGE (D) Health Policy

Hodge is committed to reducing healthcare costs for Arizona families, specifically citing the need to reduce premiums, co-pays, and the cost of medicines on his campaign site. Hodge's materials include a focus on insurance and protecting patients with pre-existing conditions.

AZ-02 (Lean Republican)

ELI CRANE (R) Health Policy

Endorsed by the NFIB,⁶ Crane has no public healthcare positions other than criticism of unvaccinated nurses being let go in New York.⁷ He opposes vaccine and mask mandates.⁸

REP. TOM O'HALLERAN (D) Health Policy

Incumbent | Rep. O'Halleran voted in favor of the Inflation Reduction Act, 9 specifically applauding the Part D out-of-pocket cap. 10 He has also introduced bipartisan legislation w/ Rep. Harshbarger (R-TN) to increase the rural physician workforce. 11 Given the older population of his district, social security and Medicare issues are very important to the Congressman, 12 and he will fight against attempts to erode either public program.

CALIFORNIA



HOUSE CA-13 (Democrat Toss Up)

ADAM GRAY (D) Health Policy

As a state legislator, Gray touts his ability to secure funding for medical education and that he persuaded an insurer (Medi-Cali) to cover continuous glucose monitors.¹³

JOHN DUARTE (R)

Health Policy

Duarte is a farmer and small business owner. He does not have any public facing healthcare policy positions.

CA-22 (Republican Toss Up)

REP. DAVID G. VALADAO (R) Health Policy

Incumbent | Rep. Valadao believes in reforms that lower the cost of healthcare while maintaining access for vulnerable populations. He believes in a market-approach to healthcare that enables choice and competition. His federal career does not include much healthcare leadership outside of rural and VA issues.

RUDY SALAS (D) Health Policy

State Assemblymember Salas' top priorities include lowering drug prices and protecting the ACA.¹⁵ In his capacity as a state elected official, he worked to expand access to mental healthcare in rural and underserved communities. He believes insulin is too expensive and supports expanding Medicare to cover dental, vision, and hearing care for seniors.

CA-27 (Republican Toss Up)

REP. MIKE GARCIA (R) Health Policy

Incumbent | Rep. Garcia's campaign website does not include healthcare as a priority. ¹⁶ Since elected, Garcia has not led on healthcare issues in the House except for a rare disease resolution. ¹⁷

CHRISTY SMITH (D) Health Policy

State Assemblymember Smith believes healthcare is a human right and supports the ACA. She advocates for increased consumer protections in healthcare and increased transparency. She also opposes the U.S. paying more for prescription drugs than other countries. Her state record includes legislation related to mental health services, reproductive freedom, and funding for free health clinics.

CALIFORNIA (cont.)



CA-41 (Lean Republican)

REP. KEN CALVERT (R)

Health Policy

Incumbent | Rep. Calvert says he will work to repeal and replace Obamacare with patient-centered healthcare solutions. His campaign website highlights his work co-chairing the ALS Caucus and appropriations work related to CDC grants for public health and assistance delivering vaccines during the COVID pandemic. 19 Calvert's official page includes outdated healthcare information related to the GOP's 2017 American Healthcare Act, indicating his federal focus has been on more appropriations work and less direct healthcare work. 20

WILL ROLLINS (D)

Health Policy

Rollins believes healthcare is a human right and wants to expand access to affordable healthcare through the ACA.²¹ His priorities include lowering the Medicare eligibility age and allowing Medicare to negotiate with drug companies. He opposes "price-gouging insurance corporations" and cuts to funding for Medicare and Medicaid. Rollins also supports efforts to strengthen Medicaid long-term services.

CA-45 (Lean Republican)

REP. MICHELLE STEEL (R)

Health Policy

Incumbent | Rep. Steel's primary healthcare focus includes opposition to Medicare for All, telehealth and concern for the long-term solvency of the Medicare trust fund.²²

JAY CHEN (D)

Health Policy

On his campaign website, Chen notes that he believes in allowing CMS to negotiate drug prices and Medicare for All. He is also in favor of reforming patent law and more regulations for pharmaceutical advertisements.²³

CA-47 (Lean Democrat)

REP. KATIE PORTER (D)

Health Policy

Incumbent | Rep. Porter voted in favor of the Inflation Reduction Act, citing the law's policies related to healthcare premiums and prescription drugs.²⁴ She also touts her effort for improving affordability for families with medical expenses. Porter supports Medicare for All and insurance coverage for mental health services.

SCOTT BAUGH (R)

Health Policy

Baugh believes in a limited, constitutional government and does not list any healthcare priorities on his campaign website.²⁵

CALIFORNIA (cont.)



CA-49 (Lean Democrat)

BRIAN MARYOTT (R)

Healthcare Policy

Maryott opposes the "nationalization" of healthcare. His top priority includes lifting federal government mandates on coverage details and increasing competition in the insurance and provider markets. He supports price transparency and enhanced care for veterans.²⁶

REP. MIKE LEVIN (D)

Healthcare Policy

Incumbent | Rep. Levin believes all Americans should have access to affordable, quality healthcare, and supports expanding the ACA. Rep. Levin voted for allowing the government to set prices for prescription drugs, wants to "explore" implementing a public option and early buy-in to Medicare, and supports reproductive rights for women and the hiring of full-time federal employees to assist Americans enrolling in healthcare.²⁷

COLORADO



SENATE

(Lean Democrat)

SEN. MICHAEL BENNET (D)

Health Policy

Incumbent | Sen. Bennet believes Americans should have affordable, high-quality healthcare. He wants to build on the progress of the ACA by championing a public option. He also supports rural health, investing in research/innovation, and improving the public health system. Bennet has worked to improve medical devices and increase transparency. He hopes to promote his proposal, Medicare-X, a public option that provides high-quality, low-cost health insurance choices, and create more competition and negotiation.²⁸

JOE O'DEA (R)

Health Policy

O'Dea is the CEO of Concrete Express Inc.,²⁹ a large heavy construction firm that advertises offering health, vision and dental as part of their employment package³⁰; he would "not vote to repeal" ACA. His campaign website does not include healthcare priorities outside of an endorsement from pro-life leaders.

HOUSE

CO-08 (Republican Toss Up)

BARBARA KIRKMEYER (R)

Health Policy

State Sen. Kirkmeyer currently sits on the state's Health and Human Services committee although healthcare policy has not been a focus during her current term as a state legislator. She has been quoted saying, "...we have progressed beyond Obamacare." 31

DR. YADIRA CARAVEO (D)

Health Policy

State Representative Caraveo commits in her campaign literature to lowering healthcare costs. As a pediatrician, she's focused on improving healthcare working conditions and forcing drug companies to lower costs. She opposes special interests from "big drug and insurance companies." 32

FLORIDA



SENATE (Lean Republican)

SEN. MARCO RUBIO (R) Health Policy

Incumbent | Sen. Rubio's campaign literature lacks any healthcare priorities. ³³ His federal career is also light on healthcare leadership but he has previously supported ending surprise billing, addressing healthcare workforce shortages, ³⁴ and reducing U.S. reliance on foreign sourcing of active pharmaceutical ingredients. ³⁵ His healthcare concerns mainly derive from a national security and supply chain perspective. During his 2016 presidential campaign, he supported a tax credit for Americans to purchase health insurance, expanding HSAs, and reforming Medicare and Medicaid. ³⁶

REP. VAL DEMINGS (D)

Health Policy

Rep. Demings supports lowering the cost of prescription drugs and standing up to special interests.³⁷ As a Member of the US House of Representatives, Demings has not prioritized healthcare issues as part of her federal agenda.

HOUSE FL-27 (Lean Republican)

REP. MARIA ELVIRA SALAZAR (R) Health Policy

Incumbent | Rep. Salazar believes in protecting people with pre-existing conditions and providing access to affordable healthcare. She advocates for increased competition, allowing health insurance to be sold across state lines and government negotiation for drug prices. 38 She has not led on healthcare issues in her federal career.

ANNETTE TADDEO (D)

Health Policy

Taddeo supports expanding Medicaid in Florida.³⁹ She also supports capping the price of insulin and standing up to special interests.

GEORGIA



SENATE (Toss Up)

SEN. RAPHAEL WARNOCK (D) Health Policy

Incumbent | Sen. Warnock's campaign website mentions standing up to special interests and rejecting PAC money from insurance and pharmaceutical companies. He supports Medicaid expansion, keeping rural hospitals open, protecting the ACA, capping insulin prices, a public option and early Medicare buy-in. His federal record includes leading the insulin OOP cap bill in the Senate.

HERSCHEL WALKER (R) Health Policy

Walker's campaign website doesn't include his positions on healthcare policies outside of his pro-life stance.⁴² Walker opposed the Inflation Reduction Act but is otherwise non-specific.

ILLINOIS



HOUSE IL-13 (Lean Democrat)

NIKKI BUDZINSKI (D) Health Policy

Budzinski supports allowing Medicare to negotiate prescription drug prices, expanding Medicare coverage to include dental and vision, and enacting a public option.⁴³ Budzinski appreciates the ACA and wants to make it more affordable and accessible. She also supports expanding telehealth.

REGAN DEERING (R)

Health Policy

Deering said the ACA isn't the "best solution" because of high premiums that businesses are forced to pay. Instead, she supports expanding services by federally qualified health centers. She also supports expanding access to fresh fruits and vegetables. 44 She will work to support rural hospitals, lower prescription drug costs, cap insulin prices, and keep the healthcare system independent. 45

IL-17 (Democrat Toss Up)

ERIC SORENSEN (D)

Health Policy

Sorensen wants to control hospital costs and ensure affordable coverage is equitable. He advocates for ACA "improvement" and negotiation in Medicare for prescription drugs.⁴⁶

ESTHER JOY KING (R)

Health Policy

Access and market-based reforms are key to King's healthcare policy agenda. She also states that "doctors should be responsible for healthcare decisions not insurance companies or Washington bureaucrats." She supports laws that encourage employers to offer health plans and mentions that gig workers should have healthcare access.⁴⁷

INDIANA



HOUSE IN-01 (Democrat Toss Up)

JENNIFER-RUTH GREEN (R) Health Policy

Green advocates for limiting government regulations on all aspects of American life, including healthcare. ⁴⁸ She opposes socialized healthcare and prioritizes "right-of-conscience" protections for healthcare workers providing care and for individuals purchasing health insurance.

REP. FRANK J. MRVAN (D) Health Policy

Incumbent | Rep. Mrvan prioritizes improving access to affordable healthcare options on his campaign website. 49 As a sitting member of the VA Committee, his federal work includes bills related to mental health and electronic health records. 50

IOWA



HOUSE IA-01 (Lean Republican)

REP. MARIANNETTE MILLER-MEEKS (R) Health Policy

Incumbent | As a physician, Rep. Miller-Meeks prioritizes health policies that ensure healthcare is accessible, affordable and allows Americans to choose what works best for them. She opposes Medicare for All and instead supports a market-based system. ⁵¹ Rep. Miller-Meeks is well versed on physician issues and her federal work includes leadership in the GOP's Healthy Future Task Force on Modernization and sponsorship of health technology-related bills.

CHRISTINA BOHANNAN (D)

Health Policy

Bohannan supports lowering the cost of healthcare, expanding Medicare to cover dental, vision and hearing care, and allowing the federal government to negotiate for drug prices.⁵²

IA-03 (Lean Republican)

ZACH NUNN (R)

Health Policy

State Sen. Nunn does not include healthcare as a key issue on his campaign literature.⁵³ His record as a state lawmaker, however, includes authorship of a few bills on healthcare related to the pandemic and veteran health; he has also supported prior authorization reforms in the state.⁵⁴

REP. CINDY AXNE (D)

Health Policy

Incumbent | Rep. Axne supports a public option that would allow Americans to buy into Medicare early. She also wants to improve the ACA and lower the cost of prescription drugs. 55 Her federal work has included leadership on bills that increase regulation of pharmaceutical advertising, speeding up access to generics, and expanding telehealth.

KANSAS

HOUSE

KS-03 (Democrat Toss Up)

REP. SHARICE DAVIDS (D) Health Policy


Incumbent | Rep. Davids was elected in 2018 but is not a leader on healthcare-related issues. Her campaign website does not highlight healthcare.

AMANDA ADKINS (R)

Health Policy

Adkins has a robust health policy agenda that includes three pillars – smarter, more transparent, and affordable healthcare. Highlights from her plan include: support for telehealth, better care coordination, improved targeting of health services through the application of social determinants of health, and greater freedom for HSAs.⁵⁶

MAINE



HOUSE ME-02 (Democrat Toss Up)

REP. JARED GOLDEN (D) Health Policy

Incumbent | Rep. Golden was the only House
Democrat to vote against Build Back Better; drug
pricing was not a part of that decision. He does
support OOP caps in Part D.⁵⁷ Given Maine's aging
population, Medicare and seniors' issues play a central
role in his health policy considerations. Rep. Golden
believes we need to move towards universal
coverage. He is working to make improvements to the
ACA and protecting Medicare and Medicaid.⁵⁸

BRUCE POLIQUIN (R) Health Policy

In 2017, when Poliquin was in office, he opposed the ACA and voted for its repeal.⁵⁹ This was a reversal from a previous repeal effort, where he voted against ACA repeal as the legislation did not have a free market alternative. Bruce worked to secure better healthcare for Veterans in Main and ensured that rural hospitals stayed open.⁶⁰

MICHIGAN



HOUSE MI-03 (Lean Democrat)

HILLARY SCHOLTEN (D) Health Policy

Scholten, a former U.S. Attorney, notes the importance of healthcare innovation in pharmaceutical research but recognizes that prices are too high. She advocates for capping prescription drug costs, insurance premiums, and insulin. She also supports paid family and medical leave.⁶¹

JOHN GIBBS (R) Health Policy

Gibbs supports greater "medical freedom" and patient-driven choice and opposes aggressive medical mandates.⁶² He criticizes the high cost of healthcare (specifically cites rising hospital and drug prices) and proposes de-regulation as a solution to increase competition and lower costs.⁶³

MI-07 (Democrat Toss Up)

REP. ELISSA SLOTKIN (D) Health Policy

Incumbent | Rep. Slotkin believes in reforming the ACA and allowing people to buy into Medicare plans. Ensuring healthcare is affordable is a top priority on her campaign website, which also includes specific ideas around transparency of prescription drug policies (real-time benefit tools and direct government negotiation).⁶⁴

TOM BARRETT (R)

Health Policy

State Senator Barrett's only healthcare-related rhetoric on his campaign website relates to his pro-life position.⁶⁵ Outside of his campaign materials, his state record is lean on healthcare.

MI-08 (Lean Democrat)

REP. DAN KILDEE (D)

Health Policy

Incumbent | Rep. Kildee touts his drug pricing, surprise billing, and Medicare and Medicaid expansion successes. 66 He is in favor of government negotiation for drugs, supports allowing more people to buy into Medicare, and tax cuts so small businesses can provide affordable health coverage to their employees. 67 He is driven by the challenges facing communities in and around Flint, MI.

PAUL JUNGE (R)

Health Policy

Junge supports protecting employer health coverage and opposes Medicare for All. He also supports patient-centered care that protects the doctor-patient relationship, speeding up the FDA process, and increasing the availability of generic drugs. He also has advocated for HSA expansion and allowing individuals and small businesses to negotiate together for better rates. ⁶⁸

MINNESOTA



HOUSE MN-02 (Democrat Toss Up)

REP. ANGIE CRAIG (D) Health Policy

Incumbent | Rep. Craig previously worked for healthcare manufacturing companies and a health plan and she plans to "stand up to Big Pharma." Her work in Congress as an Energy & Commerce Member includes sponsoring a bill that would cap insulin prices, support for Medicare negotiation with drug companies, fixing the ACA's "family glitch," and establishing a public option.⁶⁹

TYLER KISTNER (R) Health Policy

Kistner wants more choices for patients to rein in costs and improve quality and access. He supports expanding access to HSAs, improving transparency, and allowing states to sell insurance across state lines. He opposes a single-payer system.⁷⁰

NEBRASKA



HOUSE NE-02 (Republican Toss Up)

REP. DON BACON (R) Health Policy

Incumbent | Rep. Bacon supports access to affordable healthcare. He promotes working across the aisle to lower costs, increase cures, and improve preventative care. ⁷¹ Rep. Bacon has specific ACA issues he wants to reform, including the one-size-fits-all approach and lack of plan choice. He supports the preexisting condition protections and extending the time dependents can remain on parents' plans. ⁷² He has co-sponsored H.R. 19, the republican drug pricing package, and legislation to guarantee coverage of pre-existing conditions in the individual and group markets (H.R. 692).

TONY VARGAS (D) Health Policy

State Sen. Vargas routinely cites the rising cost of prescription drugs as an important issue and supports "cracking down" on pharmaceutical companies and direct negotiation. Vargas also supports a public option and modifying Medicare to be more like the VA. He touts raising \$6.5M in funding for public health departments and clinics in Nebraska. In the State Senate, Vargas has introduced several healthcare-related bills that deal with workplace health, increase funding for local health departments, and a study of local health authorities pandemic planning.

NEVADA



SENATE (Toss Up)

SEN. CATHERINE CORTEZ MASTO (D)

Health Policy

Incumbent | Sen. Cortez Masto supports defending the ACA. Her federal career includes membership on the Senate Finance Committee and leadership on legislation related to capping the cost of insulin, addressing mental health issues, and investing in Alzheimer's research. She also supports allowing Medicare to negotiate drug prices.⁷³

ADAM LAXALT (R)

Health Policy

Laxalt's only healthcare-related issues on his campaign website include his stance on pro-life and support for investigating government "policy failures" related to the COVID-19 forced shutdowns, school closures and mask mandates.⁷⁴

HOUSE

NV-01 (Democrat Toss Up)

REP. DINA TITUS (D)

Health Policy

Incumbent | Rep. Titus does not prioritize healthcare policies on her campaign website. She has not been a leader on healthcare issues in her federal career either, instead focusing on foreign affairs, transportation and homeland security.

MARK ROBERTSON (R)

Health Policy

Robertson opposes government mandates and specifically rejects any mandates as they relate to healthcare. He supports encouraging innovation in healthcare while avoiding government rationing and rejects a single-payer health system.⁷⁵

NV-03 (Democrat Toss Up)

REP. SUSIE LEE (D)

Health Policy

Incumbent | Rep. Lee does not include any healthcare priorities on her campaign website. Her record in Congress includes leadership on some bills related to mental health, rural health, and prescription drug access issues.⁷⁶

APRIL BECKER (R)

Health Policy

Becker prioritizes the importance of patient choice on her campaign website. She supports covering patients with pre-existing conditions, improved price transparency, and improving HSAs.⁷⁷

NEVADA (CONT.)



NV-04 (Lean Democrat)

REP. STEVEN HORSFORD (D)

Health Policy

Incumbent | Rep. Horsford supports bringing down the cost of prescription drugs. Rep. His career in Congress includes membership on the House Ways and Means Health Subcommittee and he's introduced bills related to health insurance reform, capping drug costs for seniors, and increasing price transparency in the prescription drug market. Personners of the cost of the prescription drug market.

SAM PETERS (R)

Health Policy

Peters supports repealing the ACA and wants patients to have more choices in healthcare "without government interference." He wants to replace the ACA with a system that will have lower costs for prescription drugs, coverage for people with preexisting conditions, and transparency in provider pricing.⁸⁰

NEW HAMPSHIRE



SENATE (Lean Democrat)

SEN. MAGGIE HASSAN (D)

Health Policy

Incumbent | Sen. Hassan led the charge opposing surprise medical bills. She "stood up to Big Pharma" by supporting Medicare negotiation of prescription drug costs. Hassan's additional priorities include mitigating substance misuse, expanding healthcare for military families, and continue to lower prescription drug costs by getting more generics to market.81 She currently sits on the Senate HELP and Finance Committees, so she is regularly involved in health policy issues.

DONALD BOLDUC (R)

Health Policy

Bolduc lists no healthcare priorities on his campaign website.82

HOUSE

NH-01 (Democrat Toss Up)

REP. CHRIS PAPPAS (D)

Health Policy

Incumbent | Rep. Pappas supports lowering the cost of prescription drugs and expanding ACA coverage. He wants to end tax breaks for pharmaceutical companies, allow importation of drugs from Canada, and increase drug pricing transparency. He also supports increased funding for community health centers.⁸³

KAROLINE LEAVITT (R)

Health Policy

Leavitt supports lowering the cost of prescription drugs by increasing price transparency and believes that "Obamacare is a disastrous policy." She supports the Trump-era rules aimed at lowering drug costs to make "Big Pharma play by the rules."84

NH-02 (Lean Democrat)

REP. ANNIE KUSTER (D) Health Policy

Incumbent | Rep. Kuster is a senior member of the House Energy & Commerce Committee. She supports reducing prescription drug prices by getting more generics on the market and allowing Medicare to negotiate drug prices. Additional priorities include support for greater NIH funding. She also founded the Bipartisan Addiction and Mental Health Task Force.85

ROBERT BURNS (R)

Health Policy

Burns owns a quality control and pharmaceutical safety company and his healthcare agenda includes bringing back pharmaceutical manufacturing to the U.S. ⁸⁶

NEW JERSEY



HOUSE NJ-07 (Lean Republican)

THOMAS KEAN JR. (R) Health Policy

State Sen. Kean supports modifications to the ACA and opposes direct government negotiation of prescription drugs. Kean's website contains little information on his policy perspectives.

REP. TOM MALINOWSKI (D) Health Policy

Incumbent | Rep. Malinowski has authored legislation allowing first responders who have retired to access Medicare at 50.87 He has also supported government price negotiation for Part D drugs.88 Rep. Malinowski has voted to protect reproductive freedom and strengthen the national stockpile for future health crises.89

NEW YORK



HOUSE

NY-01 (Lean Republican)

NICHOLAS J. LALOTA (R)

Health Policy

LaLota says he wants to work in a bipartisan manner to lower drug costs and support Medicare price negotiation.⁹⁰ He also supports price transparency and allowing consumers greater negotiation power. One of LaLota's main priorities is to get more Long Islanders insured.⁹¹

BRIDGET FLEMING (D)

Health Policy

Fleming supports a public option and universal coverage. She wants to tackle soaring premiums, end surprise billing, and lower prescription drug costs through Medicare negotiation and ACA expansion.⁹²

NY-17 (Lean Democrat)

REP. SEAN PATRICK MALONEY (D)

Health Policy

Incumbent | Rep. Maloney states that he is fighting to expand access to quality, affordable healthcare. He supports strengthening the ACA and protecting patients with pre-existing conditions, lowering the cost of premiums and deductibles, helping small businesses, and allowing Medicare to negotiate lower prescription drug prices.⁹³

MICHAEL V. LAWLER (R)

Health Policy

State Assemblyman Lawler believes we need to expand healthcare opportunities for seniors, veterans, those with disabilities, and low-income families. Lawlor's additional priorities include safeguarding Medicare's solvency and mental health policies.⁹⁴

NY-18 (Lean Democrat)

COLIN SCHMITT (R)

Health Policy

State Assemblyman Schmitt does not prioritize healthcare policies on his campaign website but as State Assemblyman did author bills^{95,96} on healthcare related to tax relief for medical expenses.

REP. PAT RYAN (D)

Health Policy

Incumbent | Rep. Ryan (elected during 2022 special election) supports increasing mental health and addiction recovery resources to the district. He touts his background increasing resources at the county level in his capacity as a member of the Ulster County Executive.⁹⁷

NEW YORK (cont.)



HOUSE

NY-19 (Democrat Toss Up)

MARC MOLINARO (R)

Health Policy

Molinaro prioritizes supporting community-driven solutions for mental health, expanding access to care and modernizing the behavioral health system. ⁹⁸ He touts his work combining the Duchess County Departments of Mental Hygiene and Health to create the Department of Community Behavioral Health. He has previously taken positions against single payer healthcare. ⁹⁹

JOSH RILEY (D)

Health Policy

Riley advocates for Medicare negotiation of prescription drugs, capping insulin prices, and creating an Office of Drug Manufacturing with the authority to manufacture generics. 100 He also advocates for restricting insurance companies from spending a percentage of premiums on anything other than healthcare. He supports lowering Medicare eligibility to 55.101 Riley believes healthcare should be a civil right for all Americans. 102

NY-22 (Republican Toss Up)

BRANDON WILLIAMS (R)

Health Policy

Williams does not include healthcare priorities on his campaign website.

FRANCIS CONOLE (D)

Health Policy

Conole supports Medicare negotiation for prescription drugs, Medicaid expansion for dental and vision, and a public option. 103

NORTH CAROLINA

HOUSE

NC-01 (Lean Democrat)

DON DAVIS (D)

Health Policy

State Sen. Davis supports accessible, quality, and affordable primary, dental, and mental healthcare. He also prioritizes maternal health issues. 104 In his capacity as a State Senator, he has voted in support of increasing healthcare competition, drug price transparency, and medical billing transparency. 105

SANDY SMITH (R)

Health Policy

Smith supports medical freedom where there are no mandates and health choices are made by the individual. 106 She wants a free and open market and advocates for healthcare competition across state lines.

NC-13 (Republican Toss Up)

WILEY NICKEL (D)

Health Policy

State Sen. Nickel believes access to quality healthcare is a human right. 107 Supporting Medicaid expansion, he wants a universal plan where people can choose coverage. He prioritizes reducing prescription costs, premiums, and expanding access to high-quality healthcare services in rural areas by improving rural infrastructure.

BO HINES (R)

Health Policy

Hines does not prioritize healthcare policies on his campaign website. 108

OHIO



SENATE (Lean Republican)

J.D. VANCE (R)

Health Policy

Vance was opposed to the ACA repeal effort under the Trump administration.¹⁰⁹ While health policy does not feature in his campaign materials,¹¹⁰ Vance's healthcare views are varied and include a focus on care for the poor, opposing direct government involvement (i.e. employer tax subsidy), and opposing provider consolidation. He also expressed support for spending reductions to government programs like Medicare.¹¹¹

REP. TIM RYAN (D)

Health Policy

Rep. Tim Ryan prioritizes lowering the cost of healthcare and increasing options and choice for patients. 112 He supports investing in rural health, expanding Medicare by lowering the eligibility age to 60 and allowing people to buy-in at 50 along with creating a public option. Ryan also supports Medicare negotiation for prescription drugs and mitigating the opioid epidemic. He voted in favor of the 21st Century Cures Act and voted for increasing funding for NIH. 113

HOUSE

OH-01 (Republican Toss Up)

GREG LANDSMAN (D)

Health Policy

Landsman supports lowering the price of prescription drugs and Medicare negotiation.¹¹⁴ As a Cincinnati Councilman he has supported public health measures and partnerships with local hospitals.¹¹⁵

REP. STEVE CHABOT (R)

Health Policy

Incumbent | Rep. Chabot supports repeal and replacement of the ACA¹¹⁶ and the Bipartisan Mental Health Bill. He believes that access to quality affordable healthcare is critical for all Americans.¹¹⁷

OH-09 (Lean Democrat)

J.R. MAJEWSKI (R)

Health Policy

Majewski's primary health concern is that parents should be able to make health decisions for their children. In his campaign materials he also expresses support for market-based solutions and keeping government limited.

REP. MARCY KAPTUR (D)

Health Policy

Incumbent | Rep. Kaptur supports the Build Back Better agenda, capping insulin prices¹²⁰, and compulsory licensing of drugs.¹²¹ She also supports expanding Medicare to include hearing, dental and vision.¹²²

OHIO (cont.)



OH-13 (Democrat Toss Up)

EMILIA SYKES (D) Health Policy

State Rep. Sykes has authored state legislation to allow for emergency 30-day supplies of critical medications to be prescribed by pharmacists.¹²³ She lists lowering the cost of drugs, capping lifesaving medications, and ensuring affordable long-term care options are available as key healthcare priorities.¹²⁴

MADISON GILBERT (R) Health Policy

Gilbert's health policy positions are centered around affordability and value-based or patient centered care. 125 Gilbert has been previously critical of the ACA and sought its repeal 126 to lower healthcare costs. She is also an advocate for a balanced budget amendment, potentially impacting Medicare.

OREGON



HOUSE OR-04 (Lean Democrat)

VAL HOYLE (D) Health Policy

Hoyle currently serves as Oregon's Labor Commissioner and previously as Oregon House Democratic Leader. She prioritizes passing universal healthcare legislation, allowing Medicaid and Medicare to negotiate for prescription drugs and ensuring those prices are available to "all Americans," lowering unaffordable deductibles and safeguarding reproductive health.¹²⁷

ALEK SKARLATOS (R)

Health Policy

Skarlatos supports increasing access to and lowering the costs of healthcare. He also supports improving the ACA, increasing healthcare price transparency, and opposes Americans paying more for prescription drugs than other countries.¹²⁸

OR-05 (Democrat Toss Up)

JAMIE MCLEOD-SKINNER (D)

Health Policy

McLeod-Skinner does not include healthcare priorities outside of protecting access to reproductive care on her campaign website.¹²⁹

LORI CHAVEZ-DEREMER (R)

Health Policy

Chavez-Deremer does not prioritize healthcare on her campaign website but her husband is a physician and together, they run several medical clinics throughout the Pacific Northwest.¹³⁰

SENATE (Toss Up)

JOHN FETTERMAN (D)

Health Policy

Lt. Governor Fetterman believes healthcare is a fundamental human right.¹³¹ He comes from a union background, which influences his health policies.¹³² Fetterman also wants to work towards universal healthcare coverage. He supports Medicare for All.¹³³

DR. MEHMET OZ, M.D. (R) Health Policy

Dr. Oz wants to expand access to private sector health plans and believes "pharmaceutical companies charge too much" so will work to "dismantle policies that lead to more expensive prescription drugs for seniors." 134

HOUSE

PA-07 (Democrat Toss Up)

LISA SCHELLER (R)

Health Policy

Lisa Scheller advocates for repealing the ACA and believes the marketplace is too expensive. She also supports drug importation and policies that allow for insurance plans to be purchased across state lines. Scheller wants to protect seniors' access to Medicare.

REP. SUSAN WILD (D)

Health Policy

Incumbent | Rep. Wild has advocated for the repeal of the noninterference clause and supported Medicare negotiation for prescription drugs. She has also supported changes to the USMCA free trade agreement to include drug importation language. Rep. Wild has committed to protecting, strengthening, and building the ACA. She is also committed to ensuring that mental healthcare resources are within reach for people across the country.

PA-08 (Democrat Toss Up)

JIM BOGNET (R)

Health Policy

Bognet believes every American deserves high quality affordable healthcare. He opposes the ACA but supports protecting patients with pre-existing conditions.¹³⁷

REP. MATT CARTWRIGHT (D)

Health Policy

Incumbent | Rep. Cartwright believes all Americans deserve high quality healthcare. He wants to expand healthcare coverage and support the ACA provisions protecting pre-existing conditions. He believes Medicare should negotiate drug prices to help lower costs. 138 He also supports expanding telehealth beyond COVID-19.

PENNSYLVANIA (cont.)

HOUSE

PA-17 (Democrat Toss Up)

JEREMY SHAFFER (R)

Health Policy

Shaffer is a strong advocate for market-driven solutions. He cites big company monopolies as a road toward socialism. ¹³⁹ Shaffer understands the value of Social Security and Medicare and will work to protect these programs. He will also fight for veterans' access to healthcare. ¹⁴⁰

CHRIS DELUZIO (D)

Health Policy

Deluzio believes that healthcare is a human right. He supports Medicare negotiation for prescription drugs as well as expansion to dental, vision and hearing. He also advocates for lowering Medicare eligibility and expanding Medicare to "achieve universal coverage." He also will work to close the Medicaid coverage gap.

TEXAS



HOUSE TX-28 (Lean Democrat)

REP. HENRY CUELLAR (D) Health Policy

Incumbent | Rep. Cuellar has been a moderate member on many issues, including healthcare. He has a record of supporting market-based approaches. Rep. Cuellar also supported the Build Back Better agenda. 142

CASSY GARCIA (R)

Health Policy

Garcia mentions a strong interest in working on healthcare and wants it to be affordable "even if you lose your job." She has demonstrated a previous opposition to the ACA.¹⁴³

VIRGINIA



HOUSE VA-02 (Democrat Toss Up)

REP. ELAINE G. LURIA (D) Health Policy

Incumbent | Congresswoman Luria has fought to preserve, strengthen, and expand healthcare coverage under the ACA. She has also been an advocate for reducing the cost of care and prescription drugs, including voting to cap the out-of-pocket price of insulin.¹⁴⁴

JEN A. KIGGANS (R) Health Policy

State Senator Kiggans includes healthcare affordability and accessibility as top priorities. She is a Nurse Practitioner and supports competition between insurance companies and cost transparency as key policies to keep health costs down. She also supports mental health accessibility, greater support for school nurses, and reducing workforce shortages in healthcare. Kiggans wants to bolster Medicare advantage, expand access to telehealth and lower Part B premiums.¹⁴⁵

VA-07 (Lean Democrat)

REP. ABIGAIL SPANBERGER (D) Health Policy

Incumbent | Rep. Spanberger believes in Medicare negotiation for drugs, she has authored and cosponsored legislation to that effect. She also supports greater transparency measures as they relate to drug pricing and "middlemen" pharmacy benefit managers, and patent reform.

YESLI VEGA (R)

Health Policy

Vega advocates for a system with more healthcare options and wants coverage to be made available across state lines. She advocates for broadening HSAs and increased price transparency for hospital procedures.¹⁴⁷

WASHINGTON



HOUSE

WA-03 (Lean Republican)

JOE KENT (R) Health Policy

Kent advocates for "deregulating" healthcare, increasing competition in the market, making medical expenses tax-deductible, and allowing individuals to purchase health insurance across state lines. He also supports removing the requirement that HSAs must be paired with high-deductible health plans.¹⁴⁸

MARIE GLUESENKAMP PEREZ (D) Health Policy

Gluesenkamp Perez wants "big money out of politics" and opposes corporate PAC donations. She supports "taking on Big Pharma" by allowing Medicare to negotiate drug prices and capping the cost of insulin. She also prioritizes small business.¹⁴⁹

WA-08 (Democrat Toss Up)

REP. KIM SCHRIER, M.D. (D) Health Policy

Incumbent | Rep. Schrier is also a practicing pediatrician and supports building on the ACA by introducing a public option "without requiring an immediate replacement of employment-based health insurance." She also supports expanding Medicare to include pediatric care, reproductive care, and family planning services. Additional priorities include free vaccines, increased premium tax credits and subsidies for middle-income earners, and federal negotiation of drug prices. 150

MATT LARKIN (R) Health Policy

Larkin's campaign website does not include any healthcare policy priorities.¹⁵¹

WISCONSIN



SENATE (Toss Up)

SEN. RON JOHNSON (R)

Health Policy

Incumbent | Healthcare is not a priority policy area for Sen. Johnson. His policy positions as a sitting member of the US Senate include switching Medicare and Social Security to discretionary funding and supporting Right to Try laws. 152

MANDELA BARNES (D)

Health Policy

Barnes supports universal healthcare, Medicare for All, and allowing Medicaid to negotiate drug prices. He also supports lowering the Medicare eligibility age to 50, capping insulin costs, and closing the healthcare coverage gap for states that haven't expanded Medicaid.¹⁵³
